

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.RubberSoulBrewing.com and Rubber Soul Brewing Co. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Rubber Soul Brewing Co. include www.RubberSoulBrewing.com and Rubber Soul Brewing. The Rubber Soul Brewing website is a Brewery site. By using the Rubber Soul Brewing website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Rubber Soul Brewing may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Rubber Soul Brewing's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
